RESOLUTION NO. 2018-R-21

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PALACIOS, TEXAS APPROVING THE SALE OF 2.2 ACRES LOCATED AT 0 SOUTH BAY ROAD; AUTHORIZING THE MAYOR TO SIGN AND THE CITY SECRETARY TO ATTEST TO ALL DOCUMENTS NECESSARY TO ACCOMPLISH SAID SALE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Palacios ("City") has previously entered into a Real Estate Sales Contract in which the Palacios Economic Development Corporation ("Corporation") agreed to purchase property generally described as 2.2 acres at 0 South Bay Blvd., formerly known as 0 Duson Dr., ("Property") and which is more specifically described Exhibit "A" attached to this Resolution; and

WHEREAS, the Corporation has obtained all necessary approvals to purchase the Property and obtained the funding necessary to pay the \$300,000.00 purchase price proposed in the sales contract, and City Council has determined that it would be in the best interest of the City to sell the Property; and

WHEREAS, all the terms and conditions of the Real Estate Sales Contract have been met to the satisfaction of the parties to the contract; NOW THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PALACIOS, TEXAS:

SECTION 1: That the City Council approves the sale of the Property described in Exhibit "A" to this Resolution to the Palacios Economic Development Corporation under the terms of the Real Estate Sales Contract previously signed by the Corporation and the City regarding this property.

SECTION 2: The Mayor or Mayor Pro Tem and the City Secretary are hereby authorized and directed to sign and attest to on behalf of and in the name of the City, the deed and any other agreements, documents, closing statements, or instruments that must be signed to complete the transaction, and to take or cause to be taken any action necessary or appropriate in connection with the sale of the Property, or which may be needed to accomplish the purposes of this resolution.

SECTION 3: That this resolution shall become effective from and after the date of its passage.



THE STATE OF TEXAS} THE COUNTY OF MATAGORDA

BEING a 2.21 acre tract of land situated in the Thomas J. Dasher Survey No. 11, Abstract 146 in Matagorda County, Texas, and being all of that certain 2.21 acre tract of land called "Section 8" of "Exhibit A" as conveyed from Southern Pacific Transportation Company to The City of Palacios according to instrument recorded in Volume 225, Page 549 of the Official Records of Matagorda County, Texas, said 2.21 acre tract of land being more fully described by metes and bounds as follows:

BEGINNING at a 5/8" steel rebar found for the northwest corner of said Southern Pacific Transportation Company tract, same being in the south right-of-way line of Commerce Street (80 foot right-of-way) for the northwest corner of the herein described tract, from which bears, South 01°05'21" East, at a distance of 400.61 feet a found 5/8" steel rebar;

THENCE, with the south right-of-way line of said Commerce Street and the north line of said Southern Pacific Transportation Company tract, North 88°55'13" East, for a distance of 299.85 feet to a set 5/8" steel rebar for the intersection of the south right-of-way line of said Commerce Street and the west right-of-way line of Sixth Street (80 foot right-of-way), same being the northeast corner of said Southern Pacific Transportation Company tract for the northeast corner of the herein described tract, from which bears, North 01°35'06" West, at a distance of 80.00 feet a found 5/8" steel rebar;

THENCE, with the west right-of-way line of said Sixth Street and the east line of said Southern Pacific Transportation Company tract, South 01°04'34" East, for a distance of 321.23 feet to a railroad rail found for the intersection of the west right-of-way line of said Sixth Street and the north right-of-way line of Duson Avenue (80 foot right-of-way), same being the southeast corner of said Southern Pacific Transportation Company tract for the southeast corner of the herein described tract, from which bears, South 48°04'27" East, at a distance of 55.06 feet a found cotton spindle;

THENCE, with the north right-of-way line of said Duson Avenue and the south line of said Southern Pacific Transportation Company tract, South 89°02'16" West, for a distance of 299.77 feet to a set 5/8" steel rebar in the north right-of-way line of said Duson Avenue, same being the southwest corner of said Southern Pacific Transportation Company tract for the southwest corner of the herein described tract, from which bears, South 01°05'21" East, at a distance of 80.00 feet a found 5/8" steel rebar;

THENCE, with the west line of said Southern Pacific Transportation Company tract, North 01°05'21" West, at a distance of 181.21 feet passing 1.2 feet right of a 5/8" steel rebar found, and continuing for a total distance of 320.61 to the POINT OF BEGINNING, CONTAINING within these metes and bounds a 2.21 acre tract of land, more or less.
