REGULAR COUNCIL MEETING

A Regular Meeting was held by the City Council of the City of Palacios on May 19, 2022, at 6:00 p.m., in the Council Chamber, 311 Henderson, Palacios, Texas 77465.

DISCUSSION AND / OR ACTION ITEMS

3. **RESOLUTION - 2022-R-12** - TDHCA Home Improvement Application. Tammy McDonald, Finance Manager presented the Resolution information. This Resolution is part of the process for the City of Palacios to assist low-income residents with improving properties within the City. The Resolution was passed, as presented, by motion. Motion/Second: Dotson/Trainor. *Vote Unanimous.*
4. **RESOLUTION - 2022-R-13** - Downtown Revitalization Grant. The Resolution was presented by Finance Manager, Tammy McDonald. This grant assists small town’s attempts to revitalize areas within a city deemed qualifying. The Resolution was approved, as presented, by motion. Motion/Second: Dotson/Trainor. *Vote Unanimous.*
5. **RESOLUTION – 2022-R-14** - Civil Rights Documents for the Downtown Revitalization Grant. Tammy McDonald, Finance Manager, presented the Resolution. This is a requirement of the grant. The Resolution was approved as presented, by motion. Motion/Second: Trainor/Dotson. *Vote Unanimous.*
6. **RESOLUTION - 2022-R-15** - Drought Contingency / Water Conservation Plan was presented by Darrell Robbins, Public Works, Director. This Resolution puts in place a plan the City will follow during times of drought in our area to assure water is available from City wells. The Resolution was approved as presented, by motion. Motion/Second: Lewis / Samora. *Vote Unanimous.*

7. **Palacios Economic Development Building** - Consider and take action regarding the maintenance recommendations for the front facade of the Palacios Economic Development Corporation building. Leland Singer, PEDC. After much discussion regarding the timing of the renovation and the permitting of the work already started without funding in place, Council agreed to discuss this agenda item further in Executive Session.
8. **Ordinance No. 2022-O-06** - Mid-Year Budget Adjustment. (Second and Final Reading). Jim Gardner, Mayor. After discussion regarding the amendments and the future budget to be set up by department levels, the budget amendments were approved by motion. Motion: Woolf / Lewis. *Vote Unanimous.*
9. **Ordinance No. 2022 – O-7** - Discuss and consider an Ordinance by the City Council of Palacios, Texas for an Ambulatory Care Service Provider. (First Reading). Jim Gardner, Mayor. This Ordinance involves non-emergent care. The first reading was approved by motion. Motion: Woolf / Lewis. *Vote Unanimous.*

EXECUTIVE SESSION (Council entered Executive / Closed Session at 7:18PM)

Called under Section 551.071 of the Texas Government Code under the following sections:

- 551.071(2) To confer with its attorney regarding matters covered by the attorney/client privilege.
- 551.072 To deliberate the purchase, exchange, lease, or value of real property if deliberation in an open meeting would have a detrimental effect on the position of the governmental body in negotiations with a third person.
- 551.074 To discuss the appointment, employment, evaluation, responsibilities, and duties, reassignment, discipline, or dismissal of an officer or employee, or to hear a complaint or charge against an officer or employee(s) City Secretary and/or City Treasurer in regard to team re-organization.

RECONVENE OPEN / REGULAR SESSION (Council reconvened at 7:58PM)

As a result of the Executive Session, Council reconvened and made the following decisions by motion:

- A. **Agenda Item #7 - Palacios Economic Development Building** - Council approved by motion to spend the requested \$40,000 (PEDC funds) for the façade renovation. Motion/Second: Dotson / Woolf. *Vote Unanimous.*
- B. **City Secretary** – Council approved, by motion, the recommendation of City Manager, Cynthia Raleigh to appoint David Holubec as City Secretary for the City of Palacios, Texas. Motion: Woolf / Glenn. *Vote Unanimous.*

ADJOURNMENT (Adjourned at 8:02PM)
