RE: 2019 EFFECTIVE, SALES TAX ADJ, DEBT AND ROLLBACK TAX RATES FINAL

The City of Palacios 2019 Effective Tax Rate is .83536.

The 2019 Effective M & O rate .92987 and the M & O Rollback Rate is 1.00425.

NOTE: These rates are unadjusted for sales tax. The Sales Tax Adjustment Rate for 2019 is .11141.


The Certified 2019 Anticipated Collection Rate is 100% and Excess Debt Collections is zero. The 2019 Debt Service of \$38,008 (\$418,383 - \$380,375 paid from other sources) generates a 2019 Debt Rate of .02318.

The 2019 Rollback Tax Rate is .91602 adjusted for sales tax (1.02743 - .11141).

The 2019 Certified Taxable Value is 198,205,240.

Please feel free to contact me if you need additional assistance. We will begin processing tax statements on or about September 16. Please make every effort to have the district's adopted rate to the tax office before this time to assure that the district will be included on the County tax bill.
