Councilmember Woolf motioned to approve an amendment to the Resolution which would add a new section to Rule 6 just above <u>Council Deliberations and Order of Speakers</u> as follows: <u>Interaction with Visitors/Citizens at open meetings</u>

- Regarding comments and questions about matter not listed on published agenda, City Staff
 and/or Council may respond in one of the following ways. A) provide relevant factual
 information, b) provide relevant City Policy information, or c) may place subject on a future
 Council Agenda for Discussion. Such comments and questions to be offered by public only
 during the Visitor/Citizen Forum agenda item.
- 2. Regarding comments and questions about matters listed on the published agenda City Staff and/or Council will listen and may respond with factual and policy information that is relevant to the agenda item being considered as part of the Council's deliberation on the matter. Such comments and questions to be offered by the public during the Visitor/Citizen Forum agenda item or during the consideration of the specific agenda item, but not both.
- 3. In all cases, recognition by the Mayor must occur before a Visitor/Citizen can speak. Registration at door for Visitor/Citizen Forum or registration ten minutes before the council meeting for specific agenda item is required to identify speaker and nature of planned communication and the agenda item to be addressed.
