Discussion by the Council of any item not on the agenda shall be limited to statements of specific factual data given in response to any inquiry, a recitation of existing policy in response to an inquiry, and/or a proposal to place the item on a future agenda. The presiding officer, during the Hearing of Residents portion of the agenda, will call on those persons who have signed up to speak in the order they have registered.

EXECUTIVE SESSION

The City Council of the city of Palacios will convene in executive session under the following sections:

- (1) 551.072; To deliberate the purchase, exchange, lease, or value of the real property if deliberation in an open meeting would have a detrimental effect on the position of the governmental body in negotiations with a third person.
